The Year End Meeting of the Town of Sparta was held on December 30th, 2024 at 12:00 PM.

Members present: Supervisor Mark Schuster, Deputy Supervisor Deb Halpenny, Council Bill Smith, and Aaron Schreiner.

Absent: Mary Ellyn Calabrese.

A motion was made by Aaron Schreiner and seconded by Deb Halpenny to accept the resignation of Sheila Duffy as Sparta Town Clerk/Tax Collector, Registrar of Vital Records, Court Clerk and custodian effective December 30, 2024. All voted yes. Carried.

A motion was made by Deb Halpenny and seconded by Bill Smith to appoint Sheila Duffy as Town Clerk/Tax Collector, Registrar of Vital Records and Court Clerk effective January 2, 2025. All voted yes. Carried.

A motion was made by Deb Halpenny and seconded by Aaron Schreiner to appoint David DiMatteo as Attorney for the Town effective January 1, 2025. All voted yes. Carried.

A motion was made by Deb Halpenny and seconded by Bill Smith to approve the 2025 Agreement to Spend Highway Funds. All voted yes. Carried.

A motion was made by Deb Halpenny and seconded by Bill Smith to move the following from General Fund as follows:

From AA2652.00 into account nos. AA1010.100, \$1.00; AA1110.400, \$273.00; AA1220.400, \$270.00; AA1315.400, \$1.00; AA1355.400, \$212.00; AA1450.400, \$1,300.00; AA1670.400, \$137.00; AA9010.800, \$21,924.00. All voted yes. Carried.

A motion was made by Aaron Schreiner and seconded by Bill Smith to move the following from the Highway Fund:

General bills were audited and approved for a total amount of \$6,769.45.

Highway bills were audited and approved for a total amount of \$41,005.19.
